### Background:

The International Republican Institute (IRI) is a nonprofit, nonpartisan, organization dedicated to advancing freedom and democracy worldwide. Since 1983, IRI has worked to develop democratic institutions and ideals, carrying out a variety of international programs to promote freedom, self-government and the rule of law worldwide. IRI provides technical assistance in the areas of political party strengthening, developing civic institutions and open elections, promoting democratic governance and advancing the rule of law.

IRI is a non-profit, non-partisan organization that conducts democracy and governance projects around the world, including in 23 countries in Africa. IRI is seeking a Long-Term Legal Framework Analyst to support the 2019 Mozambique general elections and specifically provide expertise on legal implications and legal framework issues around electoral processes.

### Period of Performance:

Date of signature through 3 months.

### Statement of Work:

- The LTA will monitor and provide in-depth analysis on any **legal implications or framework issues around the elections** in line with the *National Electoral Commission (CNE)* regulations and the laws of Mozambique. The LTA will need to develop expert level knowledge of the Mozambique electoral code, the laws establishing the CNE and other legislation and electoral regulations (such as decrees, code of conduct, ordinances, and decisions).
- The LTA will report to the Resident Program Director (RPD), continuously monitor CNE, Constitutional Court, government, and other key stakeholder activities related to the elections' legal framework, regularly produce analytical documents and weekly reports on legal issues ahead of the elections, and work closely with the RPD and other LTAs in developing regular reports and analyses. The LTA will also coordinate with the other Maputo-based analysts and the long-term analysts (LTAs) to ensure specific analysis is incorporated into findings and recommendations.

- The LTA will be based in Maputo with occasional travel to other provinces to gather more information on legal issues and precedents related to the electoral process.

**The LTA will also:**

- Provide qualitative and quantitative analysis of key institutions' adherence to the legal framework throughout the electoral process, including the pre-election/campaign, Election Day and immediate post-election environments.
- Prepare briefing materials and talking points on legal framework issues, and other advice to the observation missions, RPD and LTAs as requested and as necessary.
- When relevant, attend meetings and sessions hosted by the CNE, Mozambique government, civil society organizations (CSOs), political parties, or other related bodies.
- Work closely with the RPD to ensure that observation missions' short-term observers (STOs) are provided guidance, training and briefings to effectively observe legal framework issues in their geographic regions. The LTA may also be required to support the training of domestic observer groups when asked.
- Work closely with the Election Administration Analyst, Political Environment Analyst and Inclusion Analyst to ensure the integration of various issues into the political and campaign environment analysis.
- Maintain regular relations with election analysts of other international observation missions, as well as with international NGOs and local CSOs (including domestic observer groups) who are monitoring legal framework issues.
- Prepare regular reports as stipulated by the RPD analyzing the electoral process as it pertains to the legal framework.
- Ensure thorough legal analysis is integrated into the STOs' training materials and election observation briefings.
- Collaborate with other Analysts and the IRI Programs Team to ensure legal issues are streamlined through all reports.
- Travel to regions throughout the Mozambique as necessary.
- Support the activity of the mission, the RPD, and the other LTAs in any other aspect as necessary.

**Technical Bid & Desired Qualifications:**

All bids submitted to IRI must include:

1. Information addressing your experience in providing each of the services identified in the above Statement of Work and your proposed specific approach for providing those services to IRI under this contract, including sufficient information to determine a clear definition of services as it relates to other providers that may be involved.
2. The name, address, and telephone and facsimile numbers of the bidder (and electronic address if available);
3. Bidders shall provide contact information for a minimum of three professional references with whom the applicant has had a working relationship within the last 24-month period. IRI may contact these individuals.
4. If the Bidder is a U.S. organization/resident, or a foreign organization/resident which has income effectively connected with the conduct of activities in the U.S. or has an office or a place of business or a fiscal paying agent in the U.S., the technical bids must contain Bidder's Taxpayer Identification Number.

5. Bids will not exceed 6 pages (not including cover page), using Times New Roman font, 1" margins.

  7. Availability to deploy immediately from September 10, 2019 to December 10, 2019; dates are non-negotiable.
  8. Bachelor's Degree in law or legal studies, international relations, political science, or related subject; Master's or Law degree preferred
  9. Complete Fluency (Native or Advanced professional working level) in written and spoken English and Portuguese.
  10. A minimum of three (3) years relevant professional work experience in sub-Saharan African countries (preferably Lusophone) at the national or international level implementing programming in the field of democracy and governance, with expertise in sub-Saharan Africa (preferably Lusophone) legal systems in relation to election processes.
  11. Demonstrated ability to work under pressure in a sensitive political environment.
  12. Demonstrated ability to work as a member of an internationally and culturally diverse team, while maintaining impartiality and objectivity
  13. Exceptional interpersonal and managerial skills and cultural sensitivity to effectively interact with all levels of local stakeholders and foreign government personnel.
  14. Excellent verbal and written communications skills to effectively present information in a clear and persuasive manner.
  15. Analytical skills for interpreting complex program and political issues
  16. Experience as a long-term observer or long-term legal analyst on an international observation mission preferred.
  17. Experience in analysis of legal frameworks for elections given special consideration.
- Knowledge of PC-based word processing and e-mail technology

**Price Bids must adhere to the following criteria:**

IRI will pay directly (to the hotel, airline, train, etc.) for all preapproved travel related expenses including transportation, lodging, and meals for the contractors' participation in IRI activities and events. If it is more feasible for the contractor to use his/her own vehicle for travel to an IRI event, IRI will reimburse the cost of the transportation to the contractor based upon the prescribed formulas used by the funder of the event, calculated according to the kilometers traveled and the type of vehicle used. The daily and hourly rates submitted should, therefore, not include an assumption of costs incurred by the contractor for travel related expenses. All other expenses should be included within the daily and hourly rates, as no other expenses will be covered or reimbursed by IRI. Bids must be submitted in Currency, payments under any resulting contract will be made in this currency.

**RFQ Terms and Conditions:**

1. Prospective Bidders are requested to review clauses incorporated by reference in the section "Notice Listing Contract Clauses Incorporated by Reference".
2. IRI may reject any or all bids if such is within IRI's interest.
3. Payment will be made upon receipt of detailed invoices and deliverables/services.
4. Proof of costs incurred, such as but not limited to receipts, pictures and financial documents may be requested during and for up to three years after the end of the contract period.
5. The Bidder's initial bid should contain the Bidder's best offer.
6. IRI reserves the right to make multiple contracts or partial contracts if, after considering administrative burden, it is in IRI's best interest to do so.
7. Discussions with Bidders following the receipt of a bid do not constitute a rejection or counteroffer by IRI.
8. IRI will hold all submissions as confidential and shall not be disclosed to third parties. IRI reserves the right to share bids internally, across divisions, for the purposes of evaluating the bids.
9. By submitting a bid, Bidder agrees to comply with all terms, conditions, and provisions included in the solicitation and agreement to the services identified above and will specifically identify any disagreement with or exceptions to the terms, conditions, and provisions.
10. Bidders confirm that the prices in the bid/proposal/application/quote have been arrived at independently, without any consultation, communication, or agreement with any other bidder or competitor for the purpose of restricting competition.
11. Bidders agree to disclose as part of the bid submission:
  - a. Any close, familial, or financial relationships with IRI staff and agents. For example, the bidder must disclose if a bidder's mother conducts volunteer trainings for IRI.
  - b. Any family or financial relationship with other bidders submitting bids. For example, if the bidder's father owns a company that is submitting another bid, the bidder must state this.
  - c. Any other action that might be interpreted as potential conflict of interest.
12. IRI reserves the right to, without prior notice, reduce or cancel one or more programs listed in this RFQ, reject all applications, adjust total funds available, or cancel the RFQ in part or whole. Funding levels in the respective program areas are contingent upon continued funding, grantee performance, and/or reduction, elimination, or reallocation of federal funds by the funder, and in accordance with applicable sections within the grant award and/or agreement. IRI reserves the right to accept or deny any or all applications if IRI determines it is in the best interest to do so.
13. The agreement clauses and standard provisions maybe adjusted to reflect those of the prime award

## **Evaluation and Award Process:**

1. Bids will be evaluated by IRI for compliance with administrative requirements, recent and relevant past performance and experience in performing of similar projects by the Bidder, technical capabilities and proposed technical approach, the qualifications of the personnel for the project, and price. IRI may contact any Bidder for clarification or additional information, but Bidders are advised that IRI intends to evaluate the offers based on the written bids and reserves the right to make decisions based solely on the information provided with the initial bids. IRI may but is not obligated to conduct additional negotiations with the most highly rated Bidders prior to award of a contract and may at its sole discretion elect to issue contracts to one or more Bidders.
2. Mathematical errors will be corrected in the following manner: If a discrepancy exists between the total price proposed and the total price resulting from multiplying the unit price by the corresponding amounts, then the unit price will prevail, and the total price will be corrected. If there were a discrepancy between the numbers written out in words and the amounts in numbers, then the amount expressed in words will prevail. If the Bidder does not accept the correction, the offer will be rejected.
3. IRI may determine that a bid is unacceptable if the prices proposed are materially unbalanced between line items or sub-line items. Unbalanced pricing exists when, despite an acceptable total evaluated price, the price of one or more contract line items is significantly overstated or understated as indicated by the application of cost or price analysis techniques. A bid may be rejected if IRI determines that the lack of balance poses an unacceptable risk.
4. IRI will conduct a source selection based as follows:

IRI intends to make an award to the responsible Offeror based on the following evaluation factors:

- a) Past experience as a legal analyst or observer in sub-Saharan Africa (preferably Lusophone)-30 percent
- b) Demonstrated legal research or analysis experience and proven expertise in legal frameworks in electoral processes in the sub-Saharan African context (preferably Lusophone)- 30 percent
- c) Strong demonstrated Portuguese and English written communication skills - 20 percent
- d) Price (Daily Rate) - 20 percent

IRI intends to evaluate Offerors' proposals in accordance with these factors and make an award to the responsible Offeror whose proposal is most advantageous to the program.

5. If a cost realism analysis is performed, cost realism may be considered in evaluating performance or price.

**Notice Listing Contract Clauses Incorporated by Reference**

IRI is required to make the Bidder subject to the clauses of the prime award. The resulting agreement incorporates one or more clauses by reference, with the same force and effect as if they were given in full text. Where “flow-down” to the Bidder is appropriate and applicable, references to “USAID” or “Department of State” shall be interpreted to mean “IRI”, “Recipient” to mean “Contractor”, and “Subrecipient” to mean “the Bidder”. Included by reference are 2 C.F.R. 200 and USAID Standard Provisions for Non-US Non-governmental Organizations/US Department of State Standard Terms and Conditions.
