#### **Background**

The International Republican Institute (IRI) is a nonprofit, nonpartisan, organization dedicated to advancing freedom and democracy worldwide. Since 1983, IRI has worked to develop democratic institutions and ideals, carrying out a variety of international programs to promote freedom, self-government, and the rule of law worldwide. IRI provides technical assistance in the areas of political party strengthening, developing civic institutions and open elections, promoting democratic governance, and advancing the rule of law.

IRI Indonesia is implementing programming to facilitate the next generation of political party leaders to increase democratic resiliency. IRI hosts a variety of different trainings and consultations with political party leaders across Indonesia. To increase the accessibility and breadth of programming, IRI is seeking a learning management system to host IRI's Emerging Leaders Academy digital curriculum

#### **Period of Performance**

#### **Statement of Work**

The scope of this project includes three main areas of work:

- 1. Design and development.
- 2. Hosting.
- 3. Maintenance.
- 1. Design and development

The services required and activities will include:

- 1.1 Design of Online Learning Management Platform.
- 1.2 Compliance with IRI style and branding guidelines.
- 1.3 Site must support both English and Indonesian.

- 1.4 Design should be compatible to both mobile and PC users.
- 1.5 User interface must be user-friendly, intuitive, and easy to navigate. IRI will review initial mock-ups for web and mobile before UI/UX testing. UI/UX testing to be conducted on mobile and PC; all major browsers; in both English and Indonesian before and during development.
- 1.6 Must track user progress and status such as how much of course has been completed and scores on any pre or post tests required for programming.
- 1.7 IRI must have full access to analytics.
- 1.8 Accessibility features for people with disabilities, including the hearing and sight impaired.
- 1.9 IRI must have access to an easy to operate CMS. CMS design to be approved by IRI before development.
- 1.10 Site should be designed to operate well for users with low internet speeds.
- 1.11 Users must be able to download content for off-line use that will then be update back into the system upon connection to Wi-Fi.
- 1.12 Content will include text, video, interactive elements, tests, and worksheets.

### 2. Web Hosting

The services required and activities will include:

- 2.1 Hosting must be on a Virtual Private Server.
- 2.2 Servers should have sufficient capacity to run a database and handle a moderate traffic load.
- 2.3 Servers must be able to offer HTTP and HTTPS connection.
- 2.4 Servers should have streaming audio and video capabilities.
- 2.5 Direct connection to a major internet backbone.
- 2.6 Adequate (logical) access control mechanisms to prevent unauthorized access.
- 2.7 Adequate security measures to address and prevent cyber-attacks, such as for example, firewalls, intrusion detection systems, anomaly detection, DoS protection, etc.
- 2.8 Redundant physical infrastructure to allow for business continuity in the face of local natural disasters (floods, power cuts, fire, etc.). In other words, a second, physically distant, site should be in use or available in case of need. It should be possible to restore backups in such a way that in case of a disaster the website and portals can be restored online within 24 hours.
- 2.9 Maintenance support to include 60 hours annually or approximately 5 hours a month.
- 2.10 On-call email support with same-day response time.

#### 3. Maintenance

The services required and activities will include:

3.1 Assisting IRI with content updates when changes that must be made are not possible from the CMS user interface. It should be endeavored that as much change as possible can be made from the CMS user interface.

- 3.2 Maintain full backup of the web site through the duration of the contract. The backup, code and source files will be delivered in full to IRI on closing of the contract.
- 3.3 Must have an automated testing system that checks for broken hyperlinks on the site.
- 3.4 Verify regularly that the site is up and running and will revert to the back up whenever necessary.
- 3.5 Provide guidance and training to IRI on using the admin interface of the CMS.
- 3.6 Maintenance of the platform also includes applying security patches, clearing out log files, enlarging disk space before it runs out, sorting out security certificates and fixing bugs in the code.

IRI Indonesia invites potential providers to provide information including technical details on how each of these requirements will be implemented.

IRI Indonesia welcomes proposals which include alternative solutions to any of the detailed technical requirements presented in this scope of work, provided that the tenderer explains that this would yield at least a comparable service level.

Any intention to subcontract part of the work must be clearly stated by the provider in their technical offer. A detailed description of the company which will undertake the work is required in case it is sub-contracted and it is to be noted that sub-contractors must not subcontract further. If the identity of the subcontractor is not known at the time of submitting the technical offer, the provider who is awarded the contract will have to seek IRI Indonesia's prior written authorization before entering a sub-contract

## **Technical Proposals**

All proposals submitted to IRI must include:

- Information addressing your firm's experience in providing each of the services identified in the above Statement of Work and your proposed specific approach for providing those services to IRI under this contract, including sufficient information to determine a clear definition of services as it relates to other providers that may be involved.
- 2. The name, address, and telephone and facsimile numbers of the Offeror (and electronic address if available);
- 3. Names, titles, and telephone and facsimile numbers, and electronic addresses of persons authorized to negotiate and act on the Offeror's behalf with IRI in connection with this RFP and the resulting contract award.
- 4. Name, title, and signature of person authorized to sign the proposal. Proposals signed by an agent shall be accompanied by evidence of that agent's authority, unless that evidence has been previously furnished to the issuing office.
- 5. Offerors shall provide a list of at least five previously executed contracts of a similar nature for the last three years along with the contact details. IRI may contact the firm as reference check.
- 6. If the Offeror is a U.S. organization/resident, or a foreign organization/resident which has income effectively connected with the conduct of activities in the U.S. or has an office or a place of business or a fiscal paying agent in the U.S., the technical proposals must contain Offeror's Taxpayer Identification Number.
- 7. Proposals will not exceed 10 pages (not including cover page).

### **Price Proposals**

Price proposal must include the following criteria:

Costs should be outlined by the initial design and launch of the platform as well as the hosting and maintenance of the service

Offerors must propose a firm-fixed Unit Price for each of the deliverables identified below and in the format of the table below. The Offeror's pricing must be valid for at least 60 (sixty) calendar days after the due date for proposal submission. The proposed Unit Price should be fixed and inclusive of all costs to perform, including inspection services, transportation, taxes, import duties (if any), and other levies. To the extent that an Offeror proposed to include any pricing not reflected in the table below, such pricing must be fully described in the proposal. Proposals must be submitted in USD, payments under any resulting contract will be made in this currency.

#### **Evaluation and Award Process**

- 1. IRI may contact any Offeror for clarification or additional information, but Offerors are advised that IRI intends to evaluate the offers based on the written proposals, without discussions, and reserves the right to make decisions based solely on the information provided with the initial proposals. IRI may but is not obligated to conduct additional negotiations with the most highly rated Offerors prior to award of a contract, and may at its sole discretion elect to issue contracts to one or more Offerors.
- 2. Mathematical errors will be corrected in the following manner: If a discrepancy exists between the total price proposed and the total price resulting from multiplying the unit price by the corresponding amounts, then the unit price will prevail and the total price will be corrected. If there is a discrepancy between the numbers written out in words and the amounts in numbers, then the amount expressed in words will prevail. If the Offeror does not accept the correction, the offer will be rejected.
- 3. IRI may determine that a proposal is unacceptable if the prices proposed are materially unbalanced between line items or sub-line items. Unbalanced pricing exists when, despite an acceptable total evaluated price, the price of one or more contract line items is significantly overstated or understated as indicated by the application of cost or price analysis techniques. A proposal may be rejected if IRI determines that the lack of balance poses an unacceptable risk
- 4. IRI will conduct a source selection based as follows:

IRI intends to make an award to the responsible Offeror based on the following evaluation factors:

a) Indonesian Language Abilities - 20 percent

- b) Technical expertise in design and support 20 percent
- c) Past performance and experience in performing similar projects 20 percent
- d) Compliance with security and other administrative requirements 20 percent
- e) Price 20 percent

IRI intends to evaluate Offerors' proposals in accordance with these factors and make an award to the responsible Offeror whose proposal is most advantageous to the program.

5. If a cost realism analysis is performed, cost realism may be considered in evaluating performance or price.

#### **RFP Terms and Conditions**

- 1. Prospective Offerors are requested to review clauses incorporated by reference in the section "Notice Listing Contract Clauses Incorporated by Reference".
- 2. IRI may reject any or all proposals if such is within IRI's interest.
- 3. Proposals must be submitted in English.
- 4. Payment will be made upon receipt of invoices and deliverables/services.
- 5. Proof of costs incurred, such as but not limited to receipts, pictures and financial documents may be requested during and for up to three years after the end of the contract period.
- 6. The Offeror's initial proposal should contain the Offeror's best offer.
- 7. IRI reserves the right to make multiple awards or partial awards if, after considering administrative burden, it is in IRI's best interest to do so.
- 8. Discussions with Offerors following the receipt of a proposal do not constitute a rejection or counteroffer by IRI.
- 9. By submitting a proposal, offeror agrees to comply with all terms, conditions, and provisions included in the solicitation and agreement to the services identified above, and will specifically identify any disagreement with or exceptions to the terms, conditions, and provisions.
- 10. Any samples submitted by Offerors will not be returned to Offerors.
- 11. IRI will hold all submissions as confidential and submissions shall not be disclosed to third parties. IRI reserves the right to share proposals internally, across divisions, for the purposes of evaluating the proposals.
- 12. For any currency conversion, the exchange rate to US Dollars listed on oanda.com on the closing date of this solicitation shall be used.
- 13. By submitting a proposal, Offeror agrees to comply with all terms, conditions, and provisions included in the solicitation and agreement to the services identified above, and will specifically identify any disagreement with or exceptions to the terms, conditions, and provisions.
- 14. Offerors confirm that the prices in the proposal/proposal/application/quote have been arrived at independently, without any consultation, communication, or agreement with any other Offeror or competitor for the purpose of restricting competition.
