Background: The International Republican Institute (IRI) is a nonprofit, nonpartisan, organization dedicated to advancing freedom and democracy worldwide. Since 1983, IRI has worked to develop democratic institutions and ideals, carrying out a variety of international programs to promote freedom, self-government and the rule of law worldwide. IRI provides technical assistance in the areas of political party strengthening, developing civic institutions and open elections, promoting democratic governance and advancing the rule of law.

IRI seeks organizations to conduct publicity campaigns that raise awareness among Europeans of People’s Republic of China (PRC) malign behavior, foreign authoritarian influence in Europe and especially the coercive practices the PRC employed against Lithuania for its support for Taiwan. Campaigns will be conducted in Europe to better inform Europeans of the nature and extent of PRC influence in Europe and correct misperceptions of PRC influence. Lessons learned from evaluating the publicity campaigns will be used by IRI to inform political decision-making and messaging on PRC influence in Europe. Publicity campaigns should be informed by independently collected research as well as research provided by IRI. IRI will select at least two winners.

Eligibility: Projects fulfilling the below thematic and administrative requirements conducted by public, private, non-profit, or informal organizations are eligible for funding.

Period of Performance: September 15, 2022—January 31, 2023

Statement of Work:

IRI anticipates awarding one or more projects that focus on Lithuania. IRI further anticipates awarding one or more projects that focus on individual countries including, but not limited to, Bulgaria, Croatia, the Czech Republic, Estonia, Germany, Hungary, Latvia, Poland, Romania, Slovakia, or Slovenia. Projects should attend to the ways in which the PRC attempts to influence European foreign policy and undermine democratic solidarity. Specifically, projects should attend to how the PRC uses coercive economic practices to punish or intimidate countries seeking closer bilateral ties with Taiwan, responses from European countries and the PRC to changes in bilateral relations with Taiwan, as well as the responses of European nationals to the above. Applicants should determine the country of focus of their project. Projects focused on regions rather than specific countries will not be considered.

The selected recipient will perform the following:

- Conduct publicity campaign(s) that raise awareness among Europeans on the PRC's malign behavior, national responses to PRC malign behavior, and the rationales for those responses.
- Evaluate the publicity campaign(s) conducted in the target country.
- Successful campaigns will raise awareness, provide information backed by research, and correct misperceptions among a defined target group. Successful proposals will measure and evaluate the extent to which their campaigns raised awareness, provided information, and corrected misperceptions. Therefore, successful proposals should include detailed plans that may include the following illustrative elements:
 - Conduct secondary research on PRC influence in Europe, Lithuania-China relations, bilateral China relations, and public awareness, knowledge, and perceptions of the above
 - Identify a target audience for publicity campaigns and provide a rationale for targeting
 - Collect original or existing data corresponding to the target audience on awareness, knowledge, and perceptions of the nature and extent of PRC influence in Europe and recent Lithuania-China relations
 - Synthesize independently collected research with additional research and input from IRI and IRI-coordinated focus group discussions
 - Develop a mechanism with which to reach the target audience and a rationale for the mechanism
 - Develop publicity campaign materials and a rationale for the materials
 - Provide evidence that the developed material has been disseminated
 - Provide data detailing the extent to which the target audience has been exposed to the publicity campaign material
 - Collect original or existing data corresponding to the target audience on awareness, knowledge, and perceptions of the nature and extent of PRC influence in Europe and recent Lithuania-China relations

- Provide evidence or theory explaining the ways in which the material delivered to the target audience did or did not result in changes to awareness, knowledge, and perception
- Identify features of publicity campaigns that contribute to their success or failure and are generalizable to future campaigns

Illustrative milestones could include but are not limited to the following:

- Pre-Execution Plan (e.g., secondary research, target audience, data on the target audience, publicity campaign mechanism, publicity campaign materials)
- Evidence of Publicity Plan Execution (e.g., evidence of dissemination)
- Post-Execution Evaluation of Publicity Campaign (e.g., data on the reach of the publicity campaign, data assessing the impact of publicity campaign, evaluation of publicity campaign, identification of lessons learned)

Proposals must include the following components:

- Statement of Purpose
- Background
 - Including organizational background, registration and proof of language ability sufficient to conduct proposed activity (including national language of country of project focus and additional languages necessary to conduct publicity campaigns to significant populations speaking a language other than the national language).
- Program Goals and Objectives
- Description of Activities and Timeline
 - Milestone: a description of the deliverable or goal to be accomplished.
 - Required Deliverable: a description of how the recipient will document the completion of the deliverable.
 - Estimated Date of Completion: an estimated date by which the recipient anticipates completion of the deliverable.
 - Amount: the amount owed to the recipient for completion of the deliverable.
- Key Personnel
- Expected Outcomes

IRI anticipates awarding 1 or more Fixed Amount Subawards (FAS) to a Lithuanian organization and 2 or more FAS to organizations in other European countries. The total of all awards will be no more than 97,500 USD and individual awards will be approximately 18,000-25,000 USD, but may be larger.

The price should be presented in USD. The fixed amount award will be in USD and paid based on approval of the deliverables submitted to IRI. The set of deliverables is subject to negotiation between the recipient and IRI. The set of deliverables will be grouped into milestones in consultation with selected subaward recipients. No reimbursement is allowed.

Cost Category Budget

- The detailed budget must include the estimated costs of all personnel, travel, equipment/supplies, other activity related expenses (including expenses for monitoring and evaluation and reporting), anticipated contractual expenses, and any other direct/indirect expense.
- Costs should be projected across time, provide a unit of measure (day, month, quantity, etc.), the unit rate (if applicable), subtotals for cost categories, and a total cost for the entire project.

Technical Applications:

All applications must include a comprehensive explanation of the methods to be used for implementation. Applications should be concise.

1. The first page of the application must show the following:
 - a. The name, address, UEI Number (when required) and telephone numbers of the Applicant (and electronic address if available);
 - b. A statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation and agreement to furnish any or all items for which prices are offered;
 - c. A statement concerning whether or not the applicant has received a Negotiated Indirect Rate Cost Agreement from the US Government, currently or in the past. If yes, please attach NICRA.
 - d. Names, titles, and telephone and facsimile numbers, and electronic addresses of persons authorized to negotiate on the Applicant's behalf with IRI in connection with this RFA; and
 - e. Name, title, and signature of person authorized to sign the proposal. Applications signed by an agent shall be accompanied by evidence of that agent's authority, unless that evidence has been previously furnished to the issuing office.
 - f. The application must state the organization's indirect costs recovery methodology, which must be **ONLY** one of the following:
 - i. 10% percent de minimis rate; OR
 - ii. Current NICRA approved by the US Government (must attach copy); OR
 - iii. Direct charging of indirect costs.
2. Applicants shall provide a list of at least five previously executed awards of a similar nature for the last three years along with the contact details for each funder. IRI may contact the funder as a reference check.
3. Applicants shall provide a list of at least five program beneficiaries for previously executed grants of a similar nature for the last three years along with the contact details for each. IRI may contact the individuals as a reference check.
4. Applicants shall provide third-party evaluations of past activities if available.
5. All applications must include background on the organization's prior experience as it relates to the requested scope of work.
6. Resumes of all individuals who will be responsible for the programmatic and financial management of the award must be attached.
7. Describe current and past projects and funding sources and any potential impact current activities might have on this award.
8. Describe accounting practices and organizational infrastructure, as well as technology and intellectual property owned by the organization, which will be used to complete the scope of work.

9. Applicants shall provide audited financial statements and management letters for the last three years.
10. Applicants shall provide a copy of legal registration documents (for organizations) or one form of legal ID (individuals). An English translation should be attached if necessary.
11. Applicants shall provide a statement detailing revenue from the last three years.
12. If selected for award, applicant may be required to provide detailed allocation if it selects direct charging of indirect costs and has multiple sources of funding.
13. Using the attached checklist below, the applicant should indicate what information will be submitted for IRI's review.

Cost Applications:

The budget should be submitted in two forms: (1) a detailed, cost category budget and (2) a milestone budget.

1: Cost Category budget: A detailed budget in US Dollars including the specific line item costs outlined here must be submitted to estimate project costs. Each application should also have a detailed explanation of why the budgeted amounts are necessary for completing the scope of work. The total amount budgeted for this project is approximately 18,000-25,000 USD but may be larger.

All one-time and recurring costs must be fully described in the budget. Rates should be quoted, inclusive of all but showing separately, costs of inspection, services, transportation, taxes, import duties if any and other levies.

- Personnel – In general, employees receiving benefits from the applicant organization are considered staff. Consultants hired to assist with the program, who do not receive benefits, should be included under contractual. Identify staffing requirements by each position title and brief description of duties. For clarity, please list the annual salary of each position, percentage of time and number of months devoted to the project. (e.g., Administrative Director: \$30,000/year x 25% x 8.5 months; calculation: $\$30,000/12 = \$2,500 \times 25\% \times 8.5 \text{ months} = \$5,312.5$).
- Travel - Staff and any participant travel:
 - International airfare
 - In-country travel (not in the United States)
 - Domestic travel in the United States, if any
 - Per diem/maintenance: includes lodging, meals and incidentals for both participant and staff travel. Per diem rates may not exceed the published U.S. government allowance rates; however, institutions may use per diem rates lower than official government rates.
 - Please explain differences in fares among travelers on the same routes (e.g., project staff member traveling for three weeks whose fare is higher than that of staff member traveling for four months). Please note that all travel, where applicable, must be in compliance with the Fly America Act. For more information see <http://www.gsa.gov/portal/content/103191>.
- Supplies - List items separately using unit costs (and the percentage of each unit cost being charged to the grant) for photocopying, postage, telephone/fax, printing, and office supplies (for example, Telephone: \$50/month x 50% = \$25/month x 12 months).

- Contractual – Estimate the direct costs for items such as translation, interpretation, honoraria, local hires, legal fees, accounting/audit services, and any other contractual work that will be needed as part of the project.
 - Consultant Fees: For example lecture fees, honoraria, travel, and per diem for outside speakers or external evaluators: list number of people and rates per day (for example, 2 x \$150/day x 2 days).
- Other Direct Costs- these will vary depending on the nature of the project. The inclusion of each should be justified in the budget narrative. Audit costs can be included if they are not part of the indirect pool and only the portion of the cost associated with this program.
- Indirect/Overhead Costs – applicants can choose to budget directly for costs such as rent, utilities, technology, human resources and other general operating costs, **or** a de minimis rate of 10% can be applied to the total amount of direct expenses budgeted **or** the percentage of approved NICRA. **NOTE:** Organizations that have had an approved NICRA in currently or in the past, cannot use the 10% de Minimis; they must budget and report directly on the indirect costs of the project.

Evaluation and Award Process:

1. Applications will be evaluated by IRI for compliance with administrative requirements, previous experience of similar projects by the Applicant, technical capacity, the qualifications of the personnel for the project, and prices. IRI may contact the Applicant’s previous clients and may obtain any information related to other projects that the Applicant has executed. IRI may contact any applicant for clarification or additional information, but Applicants are advised that IRI reserves the right to make decisions based solely on the information provided with the applications. IRI may but is not obligated to conduct additional negotiations prior to issuance of a contract and may at its sole discretion elect to issue contracts to one or more applicants.
2. Mathematical errors will be corrected in the following manner: If a discrepancy exists between the total price proposed and the total price resulting from multiplying the unit price by the corresponding amounts, then the unit price will prevail and the total price will be corrected. If there were a discrepancy between the numbers written out in words and the amounts in numbers, then the amount expressed in words will prevail. If the Applicant does not accept the correction, the offer will be rejected.
3. IRI may determine that an application is unacceptable if the prices proposed are materially unbalanced between line items or sub-line items. Unbalanced pricing exists when, despite an acceptable total evaluated price, the price of one or more contract line items is

significantly overstated or understated as indicated by the application of cost or price analysis techniques. An application may be rejected if IRI determines that the lack of balance poses an unacceptable risk.

4. IRI will conduct a Technical/Price Weighted evaluation and source selection based on evaluation factors listed below. Technical evaluation factors have a total of 75 points; price evaluation has a total of 35 points. These factors will serve as the standard against which all technical information will be evaluated and identify the determination factors that Applicants should address. IRI intends to evaluate applications in accordance with the Statement of Work of this RFA and make an award to the Applicant achieving the highest combined score proposal (technical and cost), demonstrating both technical compliance and price reasonableness.
5. If a cost realism analysis is performed, cost realism may be considered in evaluating performance or price.

Evaluation of Applications:

1. The applications will be evaluated by a technical evaluation committee using the criteria shown below. When evaluating the competing applications, IRI will consider the written technical/capability information provided by the applicants, and any other information obtained by IRI through its own research.
2. The criteria listed below are presented by major category, so that Applicants will know which areas require emphasis in the preparation of their applications.
3. IRI will evaluate applications in accordance with the technical criteria and weightage shown in the table below. A total 100 points are assigned according to the following criteria:

- Prospective Applicants are requested to review clauses incorporated by reference in the section “Notice Listing Contract Clauses Incorporated by Reference”.
- All applications must be submitted in English.
- IRI may reject any or all applications if such is within IRI’s interest.
- Payment will be made in US Dollars by way of electronic transfer.

- Proof of costs incurred, such as but not limited to receipts, pictures and financial documents may be requested during and for up to three years after the end of the grant period.
- The Applicant’s initial application should contain the Applicant’s best offer. Applicants may submit modifications to their application any time before the solicitation closing date and time.
- IRI reserves the right to make multiple awards or partial awards if, after considering administrative burden, it is in IRI’s best interest to do so.
- Discussions with Applicants following the receipt of an application do not constitute a rejection or counteroffer by IRI.
