Background

The International Republican Institute (IRI) is a nonprofit, nonpartisan, organization dedicated to advancing freedom and democracy worldwide. Since 1983, IRI has worked to develop democratic institutions and ideals, carrying out a variety of international programs to promote freedom, self-government and the rule of law worldwide. IRI provides technical assistance in the areas of political party strengthening, developing civic institutions and open elections, promoting democratic governance and advancing the rule of law.

In advance of the 2023/24 national election, IRI will implement a multi-dimensional, multi-stakeholder, nationwide program that uses both in-person and online activities. The objectives of this program are 1) to enhance diverse voter participation; 2) to strengthen inclusive, citizen-responsive campaigning; and 3) to promote nonviolent competition between political parties and among citizens both during the 2023/24 election cycle and after election day. As part of its activities, IRI will conduct public opinion research to inform issue-based campaigning and enhance its understanding of Bangladesh's political dynamics.

Period of Performance

October 1, 2022 – September 20, 2023 with the option to extend for two additional years.

Statement of Work

OBJECTIVES OF THE RESEARCH

IRI aims to understand the political views and beliefs of different segments of the Bangladeshi population.

IRI needs to:

- 1. Understand how target audiences view the current state of Bangladeshi politics.** Among this target audience, how do participants describe current political conditions and recent events? What are their perceptions of major democratic and political institutions? Is democratic development (or lack thereof) a major issue to them? What do they think needs to be done to improve Bangladeshi democracy?
- 2. Understand how target audiences participate in politics or civic activities.** What political or civic activities does this target audience participate in? What actions do

they view as necessary for being a good citizen? Are they aware of all available venues for political participation or civic engagement?

METHODOLOGY

The questions above are best addressed by a focus group study. Two rounds of between six and eight groups, each lasting approximately 90-120 minutes should take place. In collaboration with IRI, the contractor will identify key segments of the population to study. This could include women, youth, and supporters of specific parties. Within these population segments, the study should aim to include a demographically inclusive sample of participants taking into account gender, age, and area of residence (e.g., division, rural areas, urban areas). Focus groups should occur in multiple divisions in both urban and rural settings, as determined jointly with IRI and the contractor.

Additional requirements:

- Participants in the same focus group session may not know one another.
- No participants may have participated in a focus group study in the past 12 months.

IRI would like the option to extend the contract for two additional years with two more rounds of 6-8 FGDs per year.

GENERAL RESPONSIBILITIES OF THE OFFEROR

Offeror will be responsible for managing all logistical aspects of the project above and should engage local support staff as necessary to complete the following:

- **Screener.** For each round, IRI will provide a draft screening questionnaire based on the specifications above. The Offeror will review offer edits within three working days of receipt. Following IRI approval, the Offeror will translate the screener into Bangla. IRI reserves the right to review the translation prior to recruitment launch. The screener for the second round will be approximately 90% identical to the first round.
- **Recruiting participants.** For each round, the Offeror will recruit all participants according to the screening criteria listed above. At least one week prior to the start of the first focus group session, the Offeror will provide a brief description of the composition of the groups in terms of age, gender, occupation, etc. Offeror should recruit 8-10 participants for each in person group as well as 2-3 alternates in case any of the original participants are unable to participate. All participants will be required to give written informed consent to participate in this study. IRI will provide draft informed consent language which may be adjusted by the bidder in order to conform to any specific legal requirements in the research country.
- **Discussion guide.** For each round, IRI will provide the draft discussion guide. Offeror will be welcome to offer suggestions for improvement and is expected to format and translate the discussion guide into Bangla. IRI reserves the right to review the translation(s.) The discussion guide for the second round will be approximately 60% identical to the first round.
- **Focus group moderator(s).** Offeror will provide one or more trained and experienced moderator(s) who is/are fully fluent in the language of discussion. They should familiarize themselves with the topic of discussion prior to fieldwork.
 - **Observation.** The Offeror will provide an opportunity for IRI staff to observe the focus group discussions.
- **Recording of focus group discussions.** Audio and/or video record all aspects of research necessary for full and accurate data collection, transcript generation and inclusion of illustrative samples in the final analytical report. Offeror will film focus groups and film

should be high quality with clear sound. If participants do not consent to videotaping, audio recordings are acceptable.

- **Transcripts.** For each round, the Offeror will provide IRI with full verbatim transcripts in English of each group that will identify each participant speaker by number or first name to link each comment to the participant's gender, exact age, education level, city and occupation.
- **Written analytical report.** For each round, Offeror will analyze all discussions, and write and edit final analytic report for review, editing and acceptance by IRI. IRI will provide a report template. The report is expected to synthesize findings across all participants and all discussion sessions, while noting to any major differences of opinions between participants and sessions. The report must present actual analysis (i.e. not mere description) and illustrative quotes from participants. The report must be in idiomatic English, and include a one or two page/slide executive summary, addressing the research needs outlined above. The length is approximately 10 pages.

- Finalized discussion guide (incl translation where applicable)
- Proposed Participant Profile
- Video/Audio recordings of the discussions, with clear audio. Recording should be delivered to IRI electronically (for example via a file transfer service) or delivered to the local IRI office.
- Full transcripts of all discussions, as described above.
- 10 page Analytic report in MS Word

TIMING

The first round of focus group discussions should be held in November 2022 and the second round should be held in September 2023 the exact timing needs to be determined in close consultation with IRI.

Technical Proposals

Please submit all bids on official ~~–~~Please limit bids to 5 pages with single spacing. Please include all pricing tables in Microsoft Excel format. Proposals should address:

1. Information addressing Bidder's experience in providing each of the services identified in the above Statement of Work and Bidder's proposed specific approach for providing those services to IRI under this contract, including sufficient information to determine a clear definition of services as it relates to other providers that may be involved.
2. The name, address, and telephone and facsimile numbers of the Bidder (and electronic address if available). If the Bidder is a firm, name(s) should be provided for individuals authorized to conduct business on behalf of the firm.
3. Bidders may provide a list of up to three references for work performed of a similar nature during the last three years, along with contact details. IRI may contact the references to evaluate past performance.

Price Proposals

Bidders must propose a firm-fixed Unit Price for each of the deliverables identified below and in the format of the table below. The Bidder's pricing must be valid for at least 60 (sixty) calendar days after the due date for proposal submission. The proposed Unit Price should be fixed and inclusive of all costs to perform, including inspection services, transportation, taxes, import duties (if any), and other levies. To the extent that a Bidder proposed to include any pricing not reflected in the table below, such pricing must be fully described in the proposal. Proposals must be submitted in USD, payments under any resulting contract will be made in this currency.

Evaluation and Award Process

1. IRI may contact any Bidder for clarification or additional information, but Bidders are advised that IRI intends to evaluate the offers based on the written proposals, without discussions, and reserves the right to make decisions based solely on the information provided with the initial proposals. IRI may but is not obligated to conduct additional negotiations with the most highly rated Bidders prior to award of a contract, and may at its sole discretion elect to issue contracts to one or more Bidders.
2. Mathematical errors will be corrected in the following manner: If a discrepancy exists between the total price proposed and the total price resulting from multiplying the unit price by the corresponding amounts, then the unit price will prevail and the total price will be corrected. If there is a discrepancy between the numbers written out in words and the amounts in numbers, then the amount expressed in words will prevail. If the Bidder does not accept the correction, the offer will be rejected.
3. IRI may determine that a proposal is unacceptable if the prices proposed are materially unbalanced between line items or sub-line items. Unbalanced pricing exists when, despite an acceptable total evaluated price, the price of one or more contract line items is significantly overstated or understated as indicated by the application of cost or price analysis techniques. A proposal may be rejected if IRI determines that the lack of balance poses an unacceptable risk.
4. IRI intends to make an award to the responsible Bidder based on the following evaluation factors:
 - a) Technical evaluation, (including technical capabilities, proposed technical approach, and personnel qualifications) – 40 percent
 1. *Recruitment plan* 10 percent
 2. *Capacity to perform scope of work* – 20 percent
 3. *Analysis plan* – 10 percent
 - b) Experience in performing similar projects – 30 percent
 1. *Experience conducting face to face FGDs in Bangladesh* – 30 percent
 - c) Price – 30 percent

IRI intends to evaluate Bidders' proposals in accordance with these factors and make an award to the responsible Bidder whose proposal is most advantageous to the program.

5. If a cost realism analysis is performed, cost realism may be considered in evaluating performance or price.

RFP Terms and Conditions

1. Prospective Bidders are requested to review clauses incorporated by reference in the section "Notice Listing Contract Clauses Incorporated by Reference".
2. IRI may reject any or all proposals if such is within IRI's interest.

3. Proof of costs incurred, such as but not limited to receipts, pictures and financial documents, may be requested during and for up to three years after the end of the contract period.
4. The Bidder's initial proposal should contain the Bidder's best offer.
5. Payment will be made upon receipt of invoices and deliverables/services.
6. Discussions with Bidders following the receipt of a proposal do not constitute a rejection or counteroffer by IRI.
7. IRI will hold all submissions as confidential and submissions shall not be disclosed to third parties. IRI reserves the right to share proposals internally, across divisions, for the purposes of evaluating the proposals.
8. For any currency conversion, the exchange rate to US Dollars listed on oanda.com on the closing date of this solicitation shall be used.
9. Every contract will contain provisions governing termination for cause and termination for convenience.
10. By submitting a proposal, offeror agrees to comply with all terms, conditions, and provisions included in the solicitation and agreement to the services identified above, and will specifically identify any disagreement with or exceptions to the terms, conditions, and provisions.
11. Offerors confirm that the prices in the proposal/proposal/application/quote have been arrived at independently, without any consultation, communication, or agreement with any other Bidder or competitor for the purpose of restricting competition.
12. If IRI continues to require the goods and services and the price remains reasonable and within market norms, resulting contract may be renewed each year for up to 5 years with 30 days' notice to the Contractor. Bidder must establish any price increase for each renewal year in the initial bid.
13. By applying to this RFP, applicant is certifying that if it is awarded a contract, none of funds payable under the resulting contract will be used to (1) procure or obtain, extend or renew a contract to procure or obtain; (2) enter into a contract (or extend or renew a contract) to procure; or (3) obtain the equipment, services, or systems that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system in compliance with the National Defense Authorization Act. Covered telecommunications equipment and services mean any of the following:

Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of the National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or

otherwise connected to, the government of a covered foreign country. ([2 CFR 200.216](#)).

14. Bidders agree to disclose as part of the proposal submission:

- Any close, familial, or financial relationships with IRI staff and agents. For example, the Bidder must disclose if a Bidder's mother conducts volunteer trainings for IRI.
- Any family or financial relationship with other Bidders submitting proposals. For example, if the Bidder's father owns a company that is submitting another proposal, the Bidder must state this.
- Any other action that might be interpreted as potential conflict of interest.

Notice Listing Contract Clauses Incorporated by Reference

IRI is required to make the contractor subject to certain flowdown clauses of the prime award. This awarded contract will incorporate one or more clauses by reference, with the same force and effect as if they were given in full text. Where "flow-down" to the contractor is applicable, references to "USAID/Department of State" shall be interpreted to mean "IRI", "Recipient" to mean "Contractor", and "Subrecipient" to mean "lower-tier subcontractor." Included by reference are the applicable provisions contained in Appendix II to 2 CFR Part 200 and USAID Standard Provisions for Non-US Non-governmental Organizations/US Department of State Standard Terms and Conditions.

IRI Obligations

Issuance of this RFP does not constitute an award commitment on the part of IRI, nor does it commit IRI to pay for costs incurred in the preparation and submission of a proposal or quotation.

CERTIFICATION REGARDING DEBARMENT, SUSPENSION, INELIGIBILITY AND VOLUNTARY EXCLUSION LOWER TIER COVERED TRANSACTIONS

This certification implements Executive Order 12549, Debarment and Suspension and the requirements set forth in 2.C.F.R. 180, Subpart C.”
