### **Background:**

The International Republican Institute (IRI) is a nonprofit, nonpartisan, organization dedicated to advancing freedom and democracy worldwide. Since 1983, IRI has worked to develop democratic institutions and ideals, carrying out a variety of international programs to promote freedom, self-government and the rule of law worldwide. IRI provides technical assistance in the areas of political party strengthening, developing civic institutions and open elections, promoting democratic governance and advancing the rule of law.

IRI's program will support Pacific Island governments and civil society in mainstreaming a gender lens into climate policy and environmental governance in ways that recognize women's agency, knowledge and leadership. The program's goal is to facilitate women's participation in decision-making platforms to improve policymaking and governance, in turn strengthening the region's resilience against environmental degradation and climate change. To achieve this, IRI will work with civil society organizations across Melanesia to develop more robust regional alliances and advocacy to support governments to translate high-level gender-responsiveness policy commitments into inclusive governance practices in the field of climate and environment issues.

IRI is seeking to contract with a local insurance company to provide high quality and competitive health insurance for at least three field staff in Suva, Fiji. The services will include enrolling and administering high quality benefits packages to all local IRI field staff. The length of coverage will be approximately 12 months. IRI may hire additional field staff in Fiji as needed that will require additional insurance services through an amendment to this agreement.

#### **Period of Performance:**

April 01, 2023 - February 30, 2024; options to extend an additional six months for an 18-month total duration.

## **Eligibility:**

- Registration or certification to administer benefit services in Fiji
- 24/7 hotline for emergency service

- Coverage provided throughout all of Fiji
- Covers all aspects listed in the scope of work
- Provides detailed explanation of policies available to field staff and associated coverage terms and limits
- Professional fluency in French

# **Scope of Work:**

- The Contractor shall provide high quality health insurance, both inpatient and outpatient, at a competitive rate for at least three field staff and dependents in Fiji. Our work is dependent on outside funding and our staffing levels are subject to change. IRI may hire additional field staff in Fiji as needed that will require additional insurance services through an amendment to this agreement.
- The Contractor will provide the following healthcare coverage and services provided, including but not limited to:
  - Maternity benefits;
  - Diagnostic investigations coverage such as CT scan, MRI scan, blood work and echocardiography;
  - Annual health checkups;
  - Scope of coverage for other major illnesses such as disabilities or an ongoing illness:
  - Vision insurance;
  - Dental insurance;
  - A list of the participating clinics included in coverage and the clinics' hours to all field staff included under coverage.

#### **Technical Bid:**

Interested bidders must present the technical bids outlining the following information:

- 10-page limit;
- 10 pt Times New Roman font;
- The potential bidder shall provide:
  - Quotes according to the insurance terms for employees enclosed.
  - A list of the total healthcare coverage and services provided, including but not limited to:
    - Maternity benefits: please specify extent of coverage, the frequency of office visits pre- and post-delivery, C-sections and emergency procedures, also detailing whether covered in full or part.
    - Specify diagnostic investigations coverage such as CT scan, MRI scan, blood work and echocardiography.
    - Specify extent of coverage for investigation and surgery for cancer.
    - Annual health checkups.
    - Scope of coverage for other major illnesses such as disabilities or an ongoing illness.
- A list of the participating clinics included in coverage and the clinics' hours.
- Monthly price per employee.
- Any possible copays or additional fees individual employees will have to pay at the time of services.

- Terms and conditions on adding or removing staff and their family members during the plan's duration.
- Past performance/References in providing quality health care in Maldives
- The list of exceptions
- The Contact information, hours of operations, and service provided for call center/hotline enclosed.

If the Bidder is a U.S. organization/resident, or a foreign organization/resident which has income effectively connected with the conduct of activities in the U.S. or has an office or a place of business or a fiscal paying agent in the U.S., the technical bids must contain Bidder's Taxpayer Identification Number.

Price information should be presented as a firm-fixed Unit Price for each of the deliverables identified below and in the format of the table below. Pricing must be valid for at least 60 (sixty) calendar days after the due date for proposal submission. The proposed Unit Price should be fixed and inclusive of all costs to perform, including inspection services, transportation, taxes, import duties (if any), and other levies. If there are any additional fees not reflected in the table below, such pricing must be fully described in the bid. Bids must be submitted in USD; payments under any resulting contract will be made in this currency.

#### **IFB Terms and Conditions:**

- 1. Prospective Bidders are requested to review clauses incorporated by reference in the section "Notice Listing Contract Clauses Incorporated by Reference". By submitting a bid, bidder agrees to comply with all terms, conditions, and provisions included in the solicitation and agreement to the services identified above, and will specifically identify any disagreement with or exceptions to the terms, conditions, and provisions.
- 2. IRI may reject any or all bids if such is within IRI's interest.
- 3. The Bidder's initial bid should contain the Bidder's best offer.
- 4. IRI reserves the right to make multiple awards or partial awards if, after considering administrative burden, it is in IRI's best interest to do so.
- 5. Discussions with Bidders following the receipt of a bid do not constitute a rejection or counteroffer by IRI.

- 6. IRI will hold all submissions as confidential and shall not be disclosed to third parties. IRI reserves the right to share bids internally, across divisions, for the purposes of evaluating the bids.
- 7. If IRI continues to require the goods and services and the price remains reasonable and within market norms, resulting contract may be extend for an additional six months with 30 days' notice to the Contractor. Bidder must establish any price increase for each renewal year in the initial bid.
- 8. Bidders confirm that the prices in the bid/proposal/application/quote have been arrived at independently, without any consultation, communication, or agreement with any other bidder or competitor for the purpose of restricting competition.
- 9. By applying to this IFB, applicant is certifying that if it is awarded a contract, none of funds payable under the resulting contract will be used to (1) procure or obtain, extend or renew a contract to procure or obtain; (2) enter into a contract (or extend or renew a contract) to procure; or (3) obtain the equipment, services, or systems that uses covered telecommunications equipment or services as a substantial or essential component of any system, or as critical technology as part of any system in compliance with the National Defense Authorization Act. Covered telecommunications equipment and services mean any of the following:
  - i. Telecommunications equipment produced by Huawei Technologies Company or ZTE Corporation (or any subsidiary or affiliate of such entities).
  - ii. For the purpose of public safety, security of government facilities, physical security surveillance of critical infrastructure, and other national security purposes, video surveillance and telecommunications equipment produced by Hytera Communications Corporation, Hangzhou Hikvision Digital Technology Company, or Dahua Technology Company (or any subsidiary or affiliate of such entities).
  - iii. Telecommunications or video surveillance services provided by such entities or using such equipment.
  - iv. Telecommunications or video surveillance equipment or services produced or provided by an entity that the Secretary of Defense, in consultation with the Director of the National Intelligence or the Director of the Federal Bureau of Investigation, reasonably believes to be an entity owned or controlled by, or otherwise connected to, the government of a covered foreign country. (2 CFR 200.216).
- 10. Bidders agree to disclose as part of the bid submission:
  - a. Any close, familial, or financial relationships with IRI staff and agents. For example, the bidder must disclose if a bidder's mother conducts volunteer trainings for IRI.
  - b. Any family or financial relationship with other bidders submitting bids. For example, if the bidder's father owns a company that is submitting another bid, the bidder must state this.
  - c. Any other action that might be interpreted as potential conflict of interest.

### **Evaluation and Award Process:**

1. IRI may contact any Bidder for clarification or additional information, but Bidders are advised that IRI intends to evaluate the offers based on the written bids and reserves

the right to make decisions based solely on the information provided with the initial bids. IRI may but is not obligated to conduct additional negotiations with the most highly rated Bidders prior to award of a contract, and may at its sole discretion elect to issue contracts to one or more Bidders.

- 2. Mathematical errors will be corrected in the following manner: If a discrepancy exists between the total price proposed and the total price resulting from multiplying the unit price by the corresponding amounts, then the unit price will prevail and the total price will be corrected. If there were a discrepancy between the numbers written out in words and the amounts in numbers, then the amount expressed in words will prevail. If the Bidder does not accept the correction, the offer will be rejected.
- 3. IRI may determine that a bid is unacceptable if the prices proposed are materially unbalanced between line items or sub-line items. Unbalanced pricing exists when, despite an acceptable total evaluated price, the price of one or more contract line items is significantly overstated or understated as indicated by the application of cost or price analysis techniques. A bid may be rejected if IRI determines that the lack of balance poses an unacceptable risk.
- 4. IRI will conduct a source selection based as follows:
  - IRI intends to make an award to the responsible Bidder based on the following evaluation factors:
  - a) Technical evaluation 40 percent
    - Variety of procedures and percentage of coverage of various insurance services under the policy 20 percent.
    - Variety of medical/dental/vision service providers available under the policy 20 percent.
  - b) Compliance with administrative requirements 20 percent

    Ability to add or remove staff and their dependents during the plan's duration 10 percent.
    - Clinic hours and location accessible to IRI local staff 10 percent.
  - c) Price 40 percent

IRI intends to evaluate bids in accordance with these factors and make an award to the responsible bidder whose proposal is most advantageous to the program.

5. If a cost realism analysis is performed, cost realism may be considered in evaluating performance or price.
