Background: The International Republican Institute (IRI) is a nonprofit, nonpartisan, organization dedicated to advancing freedom and democracy worldwide. Since 1983, IRI has worked to develop democratic institutions and ideals, carrying out a variety of international programs to promote freedom, self-government and the rule of law worldwide. IRI provides technical assistance in the areas of political party strengthening, developing civic institutions and open elections, promoting democratic governance and advancing the rule of law.

For over a decade, the National Endowment for Democracy's investment in WDN has built a platform to connect aspiring and experienced women leaders around the world, coalescing diverse, multi-sector groups of women and empowering them to meaningfully participate and take on leadership roles within the political process. WDN's reach now extends to more than 12,000 global members in more than 115 countries and over 22 longstanding partner organizations, including 16 Country Chapters.

WDN bases its women's empowerment programming on the following tiered approach to engagement:

1. **Illuminate a Path:** WDN broadens women's understanding of how to participate in political processes and why it is important. WDN also provides leadership and skills training that builds self-confidence and introduces them to avenues for public engagement.
2. **Build a Critical Mass:** WDN strengthens the ability of women to lead by helping them develop connections within civic and political networks and building their skills to run for office, actively participate in civil society and political parties, as well as undertake activism.
3. **Equip and Inspire:** WDN equips women with the technical capacity and soft skills to serve effectively once in positions of leadership to promote gender-responsive policies and resource mobilization and inspire a new generation of women leaders.

Thematic focus topics for WDN include but are not limited to:

- Gender-based violence, including violence against women in politics and online violence against women.

- Gender-responsive policy, including on issues of women's economic empowerment and climate governance and resilience
- Women's political leadership
- Male allyship

Eligibility: Individuals and Organizations:

- Experience working on gender-related issues, with civil society organizations and/or government officials for at least one month.

Period of Performance: Upon signing of agreement, up to 31 August 2024.

Statement of Work: Application should respond to one of the program objectives below.

The program objectives include:

Objective 1: To increase the capacity of civil society actors, government officials and community leaders to address structural barriers and increase awareness regarding sociocultural gender norms that restrict women's full participation in public life.

1.1: Subawardee will submit action plans addressing barriers to women's full participation in public life that that participants implemented or will implement.

1.2: Subawardee will submit policies, recommendations, or amendments to a national or subnational government entity or gain commitments from a civil society actor, government official, or community leader to address the barriers to women's political participation in public life.

Objective 2: To build the capacity of women to participate and achieve leadership positions in social movements, elected office, civil society organizations, political parties, and other aspects of public life.

2.1: Subawardee will administer pre- and post-activity surveys and report lessons learned from activities addressing barriers to women's political participation in public life.

2.2: Subawardee will report participants who run and/or are elected to office post-activity and conduct follow-up interviews as necessary.

The subawardee will be required to conduct one or more activities that follow at least one of the below topics:

- Subawardee will work with either civil society actors, government officials or community leaders as primary beneficiaries.
- Programming will develop and address gender-responsive policies that address structural barriers including but not limited to WDN's subtopic areas (see below for more details) and/or
- Programming will address sociocultural gender norms that restrict women's full participation in public life by raising awareness and/or promoting gender equitable norms.
- Partners are encouraged to utilize WDN's toolkits, including the Gender-Responsive Policymaking Toolkit (GPRT), Violence Against Women in Politics toolkit (VAWP), Transformative Alliances Toolkit (TAT), Ask a Woman to Run Toolkit, and the Women's Leadership School curricula in their programming.

WDN encourages proposals that focus, but are not limited to, the following subtopics:

- Gender-based violence (including violence against women in politics and online violence against women)
- Gender-responsive policy (including on issues of women's economic empowerment and climate governance and resilience)
- Women's political participation and leadership (including women, peace and security)
- Transformative allies / male allies

If the subawardee has received funding from WDN previously, all proposals should include details on how their proposed program will build upon progress made during the previous subawards.

The subawardee is responsible for the following:

- Arrange and implement activities that contribute to either objective provided above. At least one activity is expected per award. Examples include advocacy meetings, workshops, and trainings.
- Develop a work plan and monitoring and evaluation (M&E) plan that must be adhered to throughout the project life cycle. At the start of the award, WDN will provide IRI templates to be used for the duration of the subaward.
- Collect M&E data in accordance with the approved M&E plan.
- Maintain close contact with participants for M&E in the post-programming period. Follow-up sessions should measure the impact of the program towards stated objectives of WDN.

REPORTING REQUIREMENTS

Subawardees will adhere to all reporting requirements listed below. The exact format for preparation of and timing for submission of all reports will be determined in collaboration with WDN and will be included in the terms and conditions of the award.

- **Monitoring, Evaluation and Learning (MEL) Workplan:** The subawardee will be required to submit a MEL workplan during the award. Workplans will include information on how the subawardee will conduct M&E throughout the project's lifecycle, including plans for evaluating knowledge gained (if applicable) and completing follow-up with beneficiaries. A MEL workplan template will be provided by WDN at the start of the award.
- **Activity Reports:** The subawardee will be required to submit activity reports immediately after each activity. Reports will include details of the activity, an agenda, disaggregated participant list, and immediate outputs. The reports will also respond to indicators approved by WDN and will utilize data collection methods approved by WDN. An activity report template will be provided by WDN at the start of the award.
- **Follow-up Report:** The subawardee will be required to submit a follow-up report at the end of the subaward period. This report should detail follow-up

conducted by the subawardee that documents results and analyzes progress towards objectives. Subawardee will be required to use WDN-provided templates. A follow-up report template will be provided by WDN at the start of the award.

Technical Applications:

All applications must include a comprehensive explanation of the methods to be used for implementation. Applications must not exceed 5 pages.

1. The first page of the application must show the following:
 - a. The name, address, UEI Number (when required) and telephone numbers of the Applicant (and electronic address if available);
 - b. A statement specifying the extent of agreement with all terms, conditions, and provisions included in the solicitation and agreement to furnish any or all items for which prices are offered;
 - c. A statement concerning whether or not the applicant has received a Negotiated Indirect Rate Cost Agreement from the US Government, currently or in the past. If yes, please attach NICRA.
 - d. Names, titles, and telephone and facsimile numbers, and electronic addresses of persons authorized to negotiate on the Applicant's behalf with IRI in connection with this RFA; and
 - e. Name, title, and signature of person authorized to sign the proposal. Applications signed by an agent shall be accompanied by evidence of that agent's authority, unless that evidence has been previously furnished to the issuing office.
 - f. The application must state the organization's indirect costs recovery methodology, which must be **ONLY** one of the following:
 - i. 10% percent de minimis rate; OR
 - ii. Current NICRA approved by the US Government (must attach copy); OR
 - iii. Direct charging of indirect costs.
2. Applicants shall provide a list of at least five previously executed awards of a similar nature for the last three years along with the contact details for each funder. IRI may contact the funder as a reference check.
3. Applicants shall provide a list of at least five program beneficiaries for previously executed grants of a similar nature for the last three years along with the contact details for each. IRI may contact the individuals as a reference check.
4. Applicants shall provide third-party evaluations of past activities if available.
5. All applications must include background on the organization's prior experience as it relates to the requested scope of work.
6. Resumes of all individuals who will be responsible for the programmatic and financial management of the award must be attached.
7. Describe current and past projects and funding sources and any potential impact current activities might have on this award.
8. Describe accounting practices and organizational infrastructure, as well as technology and intellectual property owned by the organization, which will be used to complete the scope of work.
9. Applicants shall provide audited financial statements and management letters for the last three years.

10. Applicants shall provide a copy of legal registration documents (for organizations) or one form of legal ID (individuals). An English translation should be attached if necessary.
11. Applicants shall provide a statement detailing revenue from the last three years.
12. If selected for award, applicant may be required to provide detailed allocation if it selects direct charging of indirect costs and has multiple sources of funding.
13. Using the attached checklist below, the applicant should indicate what information will be submitted for IRI's review.
14. Applications must be submitted in English.
15. Applications must detail all past external funding

Cost Applications:

The budget should be submitted in two forms: (1) a detailed, cost category budget and (2) a milestone budget.

1: Cost Category budget: A detailed budget in US Dollars including the specific line item costs outlined here must be submitted to estimate project costs. Each application should also have a detailed explanation of why the budgeted amounts are necessary for completing the scope of work. The total amount budgeted for this project must not exceed **\$10,000 USD**.

All one-time and recurring costs must be fully described in the budget. Rates should be quoted, inclusive of all but showing separately, costs of inspection, services, transportation, taxes, import duties if any and other levies.

- *Personnel* – In general, employees receiving benefits from the applicant organization are considered staff. Consultants hired to assist with the program, who do not receive benefits, should be included under contractual. Identify staffing requirements by each position title and brief description of duties. For clarity, please list the annual salary of each position, percentage of time and number of months devoted to the project. (e.g., Administrative Director: \$30,000/year x 25% x 8.5 months; calculation: $\$30,000/12 = \$2,500 \times 25\% \times 8.5 \text{ months} = \$5,312.5$).
- *Travel* - Staff and any participant travel:
 - International airfare
 - In-country travel (not in the United States)
 - Domestic travel in the United States, if any
 - Per diem/maintenance: includes lodging, meals and incidentals for both participant and staff travel. Per diem rates may not exceed the published U.S. government allowance rates; however, institutions may use per diem rates lower than official government rates.
 - Please explain differences in fares among travelers on the same routes (e.g., project staff member traveling for three weeks whose fare is higher than that of staff member traveling for four months). Please note that all travel, where applicable, must be in compliance with the Fly America Act. For more information see <http://www.gsa.gov/portal/content/103191>.
- *Supplies* - List items separately using unit costs (and the percentage of each unit cost being charged to the grant) for photocopying, postage, telephone/fax, printing, and

office supplies (for example, Telephone: \$50/month x 50% = \$25/month x 12 months).

- *Contractual* – Estimate the direct costs for items such as translation, interpretation, honoraria, local hires, legal fees, accounting/audit services, and any other contractual work that will be needed as part of the project.
 - *Consultant Fees*: For example lecture fees, honoraria, travel, and per diem for outside speakers or external evaluators: list number of people and rates per day (for example, 2 x \$150/day x 2 days).
- *Other Direct Costs*- these will vary depending on the nature of the project. The inclusion of each should be justified in the budget narrative. Audit costs can be included if they are not part of the indirect pool and only the portion of the cost associated with this program.
- *Indirect/Overhead Costs* – applicants can choose to budget directly for costs such as rent, utilities, technology, human resources and other general operating costs, **or** a de minimis rate of 10% can be applied to the total amount of direct expenses budgeted **or** the percentage of approved NICRA. **NOTE**: Organizations that have had an approved NICRA in currently or in the past, cannot use the 10% de Minimis; they must budget and report directly on the indirect costs of the project.

Evaluation and Award Process:

1. Applications will be evaluated by IRI for compliance with administrative requirements, previous experience of similar projects by the Applicant, technical capacity, the qualifications of the personnel for the project, and prices. IRI may contact the Applicant’s previous clients and may obtain any information related to other projects that the Applicant has executed. IRI may contact any applicant for clarification or additional information, but Applicants are advised that IRI reserves the right to make decisions based solely on the information provided with the applications. IRI may but is not obligated to conduct additional negotiations prior to issuance of a contract and may at its sole discretion elect to issue contracts to one or more applicants.
2. Mathematical errors will be corrected in the following manner: If a discrepancy exists between the total price proposed and the total price resulting from multiplying the unit price by the corresponding amounts, then the unit price will prevail and the total price will be corrected. If there were a discrepancy between the numbers written out

in words and the amounts in numbers, then the amount expressed in words will prevail. If the Applicant does not accept the correction, the offer will be rejected.

3. IRI may determine that an application is unacceptable if the prices proposed are materially unbalanced between line items or sub-line items. Unbalanced pricing exists when, despite an acceptable total evaluated price, the price of one or more contract line items is significantly overstated or understated as indicated by the application of cost or price analysis techniques. An application may be rejected if IRI determines that the lack of balance poses an unacceptable risk.
4. IRI will conduct a Technical/Price Weighted evaluation based on evaluation factors listed below. These factors will serve as the standard against which all technical information will be evaluated and identify the determination factors that Applicants should address. IRI intends to evaluate applications in accordance with the Statement of Work of this RFA
5. If a cost realism analysis is performed, cost realism may be considered in evaluating performance or price.

Evaluation of Applications:

1. The applications will be evaluated by a technical evaluation committee using the criteria shown below. When evaluating the competing applications, IRI will consider the written technical/capability information provided by the applicants, and any other information obtained by IRI through its own research.
2. The criteria listed below are presented by major category, so that Applicants will know which areas require emphasis in the preparation of their applications.
3. IRI will evaluate applications in accordance with the technical criteria and weightage shown in the table below.

- All applications must be submitted in English.
- IRI may reject any or all applications if such is within IRI's interest.
- Payment will be made in US Dollars by way of electronic transfer.
- Proof of costs incurred, such as but not limited to receipts, pictures and financial documents may be requested during and for up to three years after the end of the grant period.

- The Applicant’s initial application should contain the Applicant’s best offer. Applicants may submit modifications to their application any time before the solicitation closing date and time.
- IRI reserves the right to make multiple awards or partial awards if, after considering administrative burden, it is in IRI’s best interest to do so.
- Discussions with Applicants following the receipt of an application do not constitute a rejection or counteroffer by IRI.

If it is later determined that the prospective lower tier participant knowingly rendered an erroneous certification, in addition to other remedies available to the Federal Government, the department or agency with which this transaction originated may pursue available remedies, including suspension and/or debarment.
3. The prospective lower tier participant shall provide immediate written notice to the person to which this proposal/bid/application/quote is submitted if at any time the prospective lower tier participant learns that its certification was erroneous when submitted or has become erroneous by reason of changed circumstances.
